have regained some considerable share of his former health; but the improvement was only apparent, for on the night of the 12th of April he was seized with apoplexy, became rapidly unconscious, and died early on the morning of April 13th, 1870, in his fifty-fifth year. He leaves no record behind him to testify to his work beyond that which is indelibly written on the hearts of all his friends and patients.
